GROUND FLOOR:- At ground floor there are 9 Nos Class room, 1 No.Staff room, 1 No.Principal room, 1 No.Head office, 1 No.Store room, 1 No.Reception, 1 No.Girls Toilet, 1 No.Boys Toilet, 1 No. Kids Toilet, 1 No. Staff Toilet and 2No. Stair case.

FIRST FLOOR:- At first floor there are 8 Nos Class room, 1 No. Computer room, 1 No. Math lab, 1 No.Composite lab, 1 No.Library, 1 No.Store room, 1 No.Girls Toilet, 1 No.Boys Toilet, 1 No. Staff Toilet and 2 no Stair case.

The building is having frame structure with column beams and R.C.C. slab & load bearing walls. The structure stability certificate has been also enclosed, which issued by Sanjeev Gupta, Chartered Engineer, Govt. of India Registered valuervide reference no. PB/CEC/FBD/3416/2022-23 dated 03.03.2023 .The fire NOC has been issued by Fire Station Officer, Sector-15 Faridabad vide memo no. FS/2022/137 dated 16.08.2022 & valid for Three years. The Hygiene certificate is also issued by O/o Civil Surgeon, Faridabad vide their office No HHC/Fbd/2023-24/045 dated 27.04.2023 valid up to 31.03.2024.

Keeping in view all the circumstances and the documents submitted by the applicant, the building is seems to be safe. The building safety certificate has been issued to the above mentioned school for the time period of one year. The periodical inspection of the school building must be ensured.
